##### **REGISTRATION FEES**

Rs. 10,000 for two parties, Rs.3000 for each additional party, arrayed as respondent.

##### **CHALLENGES**

Rs.3000 per hour of time spent by the Registry for each challenge, payable by the party who challenges.

### GENERAL INFORMATION

Postage and communication charges for correspondence with arbitrators, mediators and conciliators shall be charged extra.

All travel, accommodation and halting expenses of arbitrators, mediators and conciliators, who are required to travel to a place other than his or her normal place of residence, has to be met by the parties. Parties need to co-ordinate with the respective arbitrators, mediators and conciliators.

Local conveyance arrangements have to be made by the parties to enable the arbitrators, mediators and conciliators to reach the venue of dispute resolution.
